Study Visa Requirements:

1. You are responsible to apply for a study visa at a South African **embassy, consulate or high commission abroad**, which is normally in your home country.
2. Please confirm the requirements for a study visa with the South African representative where you plan to submit your application.

Schedule of payment

- The following instalments have to be paid on or before the dates as set out:
 31 MAY - At least 75% of the total account, taking into consideration the fees that you paid at registration.
 30 SEPTEMBER - The outstanding balance on your student fees account.
- All outstanding amounts on student accounts for previous year(s) must be paid before a student will be allowed to register for a subsequent year. The total amount and the first instalment payable at registration quoted above do not include possible arrears.
- In the case of sponsorship, you will have to submit a formal sponsorship confirmation letter. In this instance the deposit is payable along with 75% of annual fees by the end of March 2019 and the balance due by 30 September (Not applicable to International students).
