The Journal of Accounting in Emerging Economies (JAEE) and the University of Stellenbosch Business School (USB) will offer a joint paper development workshop in beautiful Cape Town, South Africa, on 6th of December 2019. Aimed at emerging scholars and doctoral students, the main objective is to provide feedback on research papers which are at an advanced stage of completion, compliant with JAEE style guide.

The workshop will assist in developing the research skills of these scholars on issues that are of relevance to JAEE. The intention

is to dedicate a special issue of JAEE to papers presented at the workshop.

As part of the workshop, JAEE editors and senior scholars will lead sessions and provide insights on publishing strategies and techniques, as well as in-depth feedback on selected papers. A maximum of 15 papers will be selected for presentation.

The keynote speaker is Shahzad Uddin, Professor of Accounting and the Director of Essex Accounting Centre at Essex Business School, University of Essex and the editor of the JAEE.
